<p><b>Securities<sup>2</sup></b>  Any beneficial interest in securities of a body where –  (a) that body (to my knowledge) has a place of business or land in the area of the Council named above; and  (b) either –  (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or  (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I or my spouse or partner* has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>


